The Farm Bill Requires State Foresters to Develop & Submit...

- **1.** A statewide assessment of forest resource conditions, including:
 - A. the conditions and trends of forest resources in [the] state;
 - **B.** the threats to forest lands and resources in [the] state consistent with the national priorities;
 - C. any areas or regions of [the] state that are a priority; and
 - D. any multi-state areas that are a regional priority.



The Farm Bill Requires State Foresters to Develop & Submit...

- 2. A long-term statewide forest resource strategy, including:
 - A. strategies for addressing threats to forest resources in the state outlined in the assessment; and
 - B. a description of the resources necessary for the State Forester from all sources to address the statewide strategy.

Complete by December 2020 to remain eligible to receive CFAA funds.




State Strategy: A Plan to Address Priorities

- How state will invest federal and other resources.
- Timeline for implementation.
- ID partner and stakeholder involvement.
- Monitor outcomes and revise actions.
- Accomplish S&PF national objectives.
- How S&PF programs will be used.
- Incorporate existing plans.



National State & Private Forestry Priorities

- Conserve and manage working forest landscapes for multiple values and uses.
- Protect forests from threats.
- Enhance public benefits from trees and forests.




Issues, Threats, and Opportunities


