



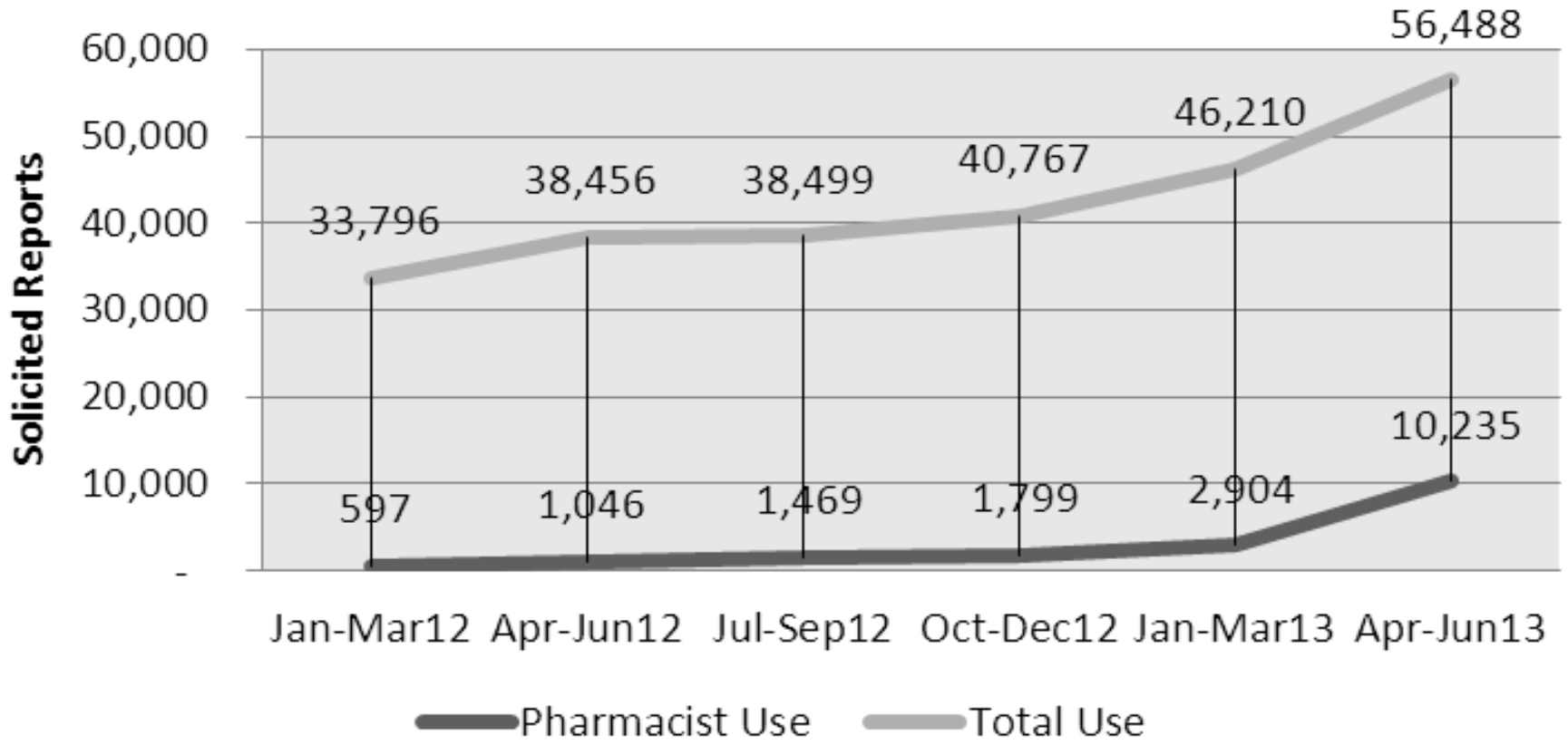

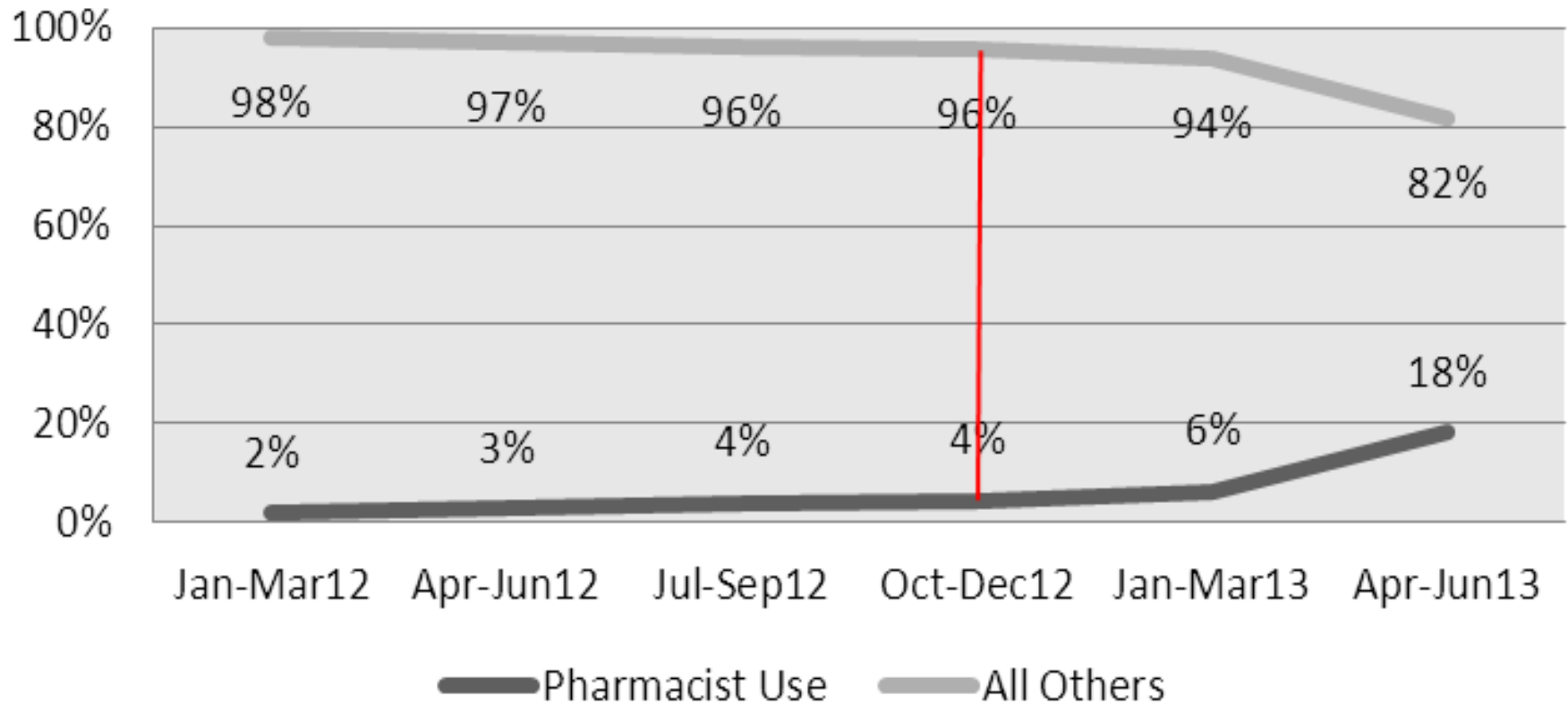

# Solicited Report Utilization 18 Month View

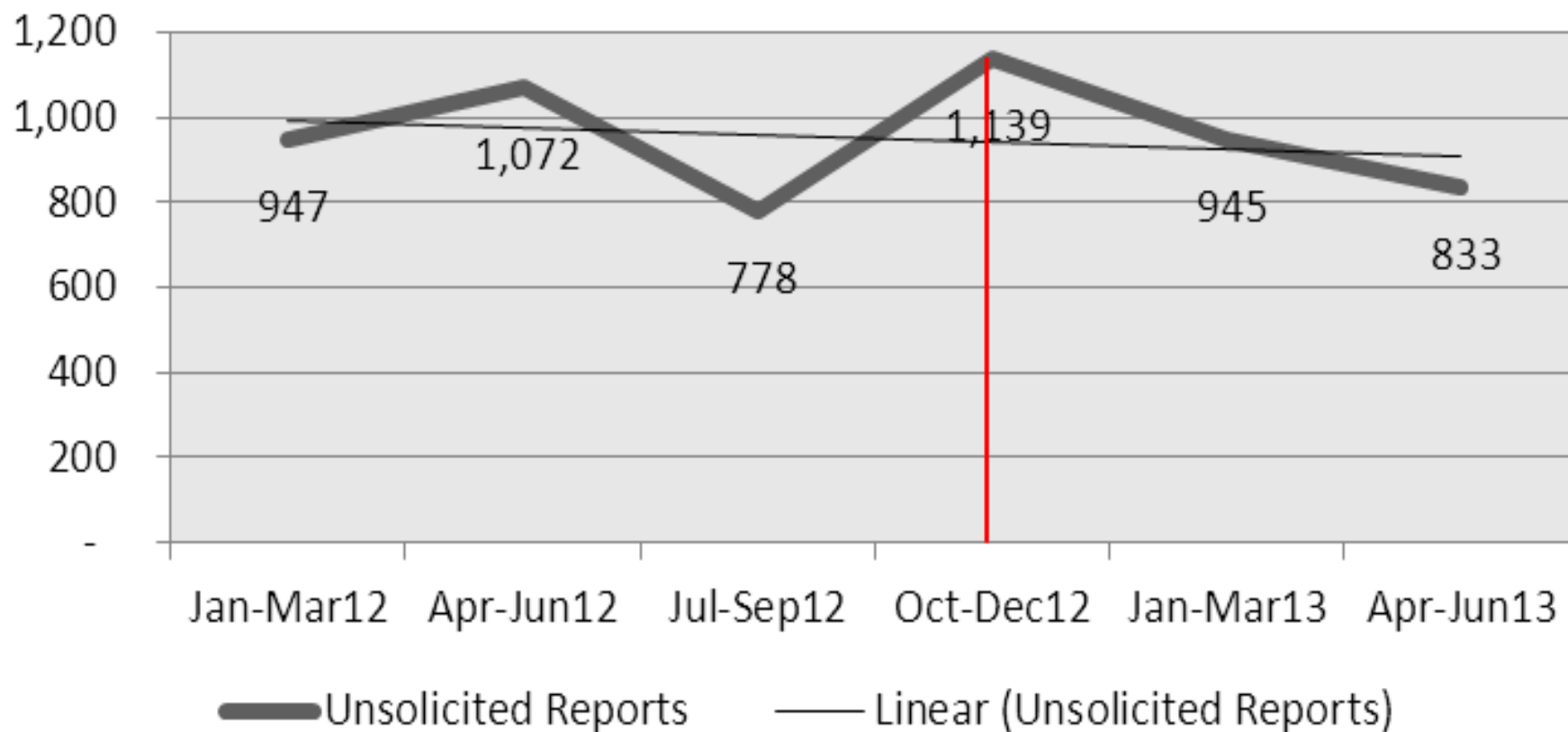

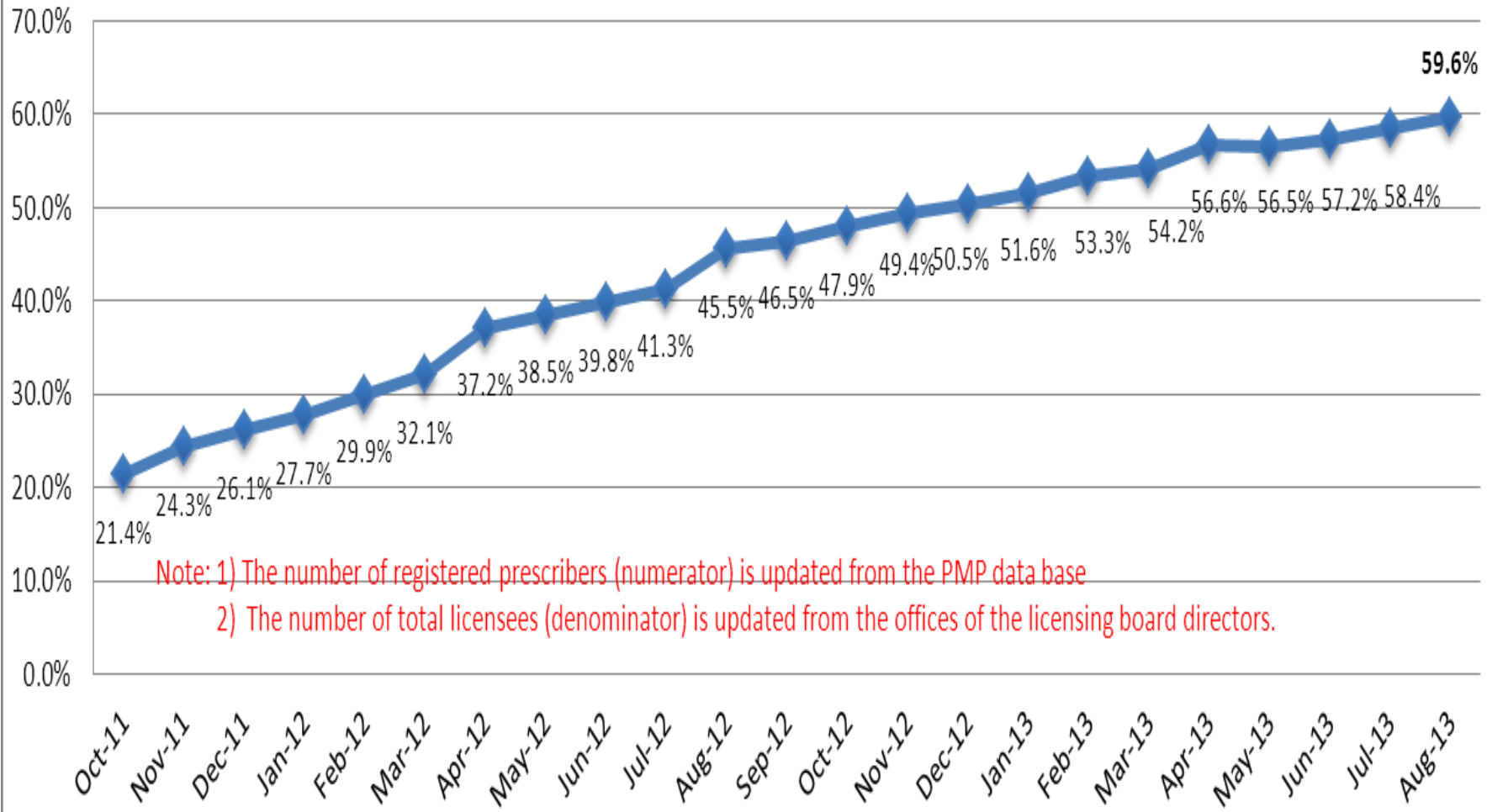
# Percentage Solicited Report Utilization 18 Month View



## Unsolicited Reports 18 Month View

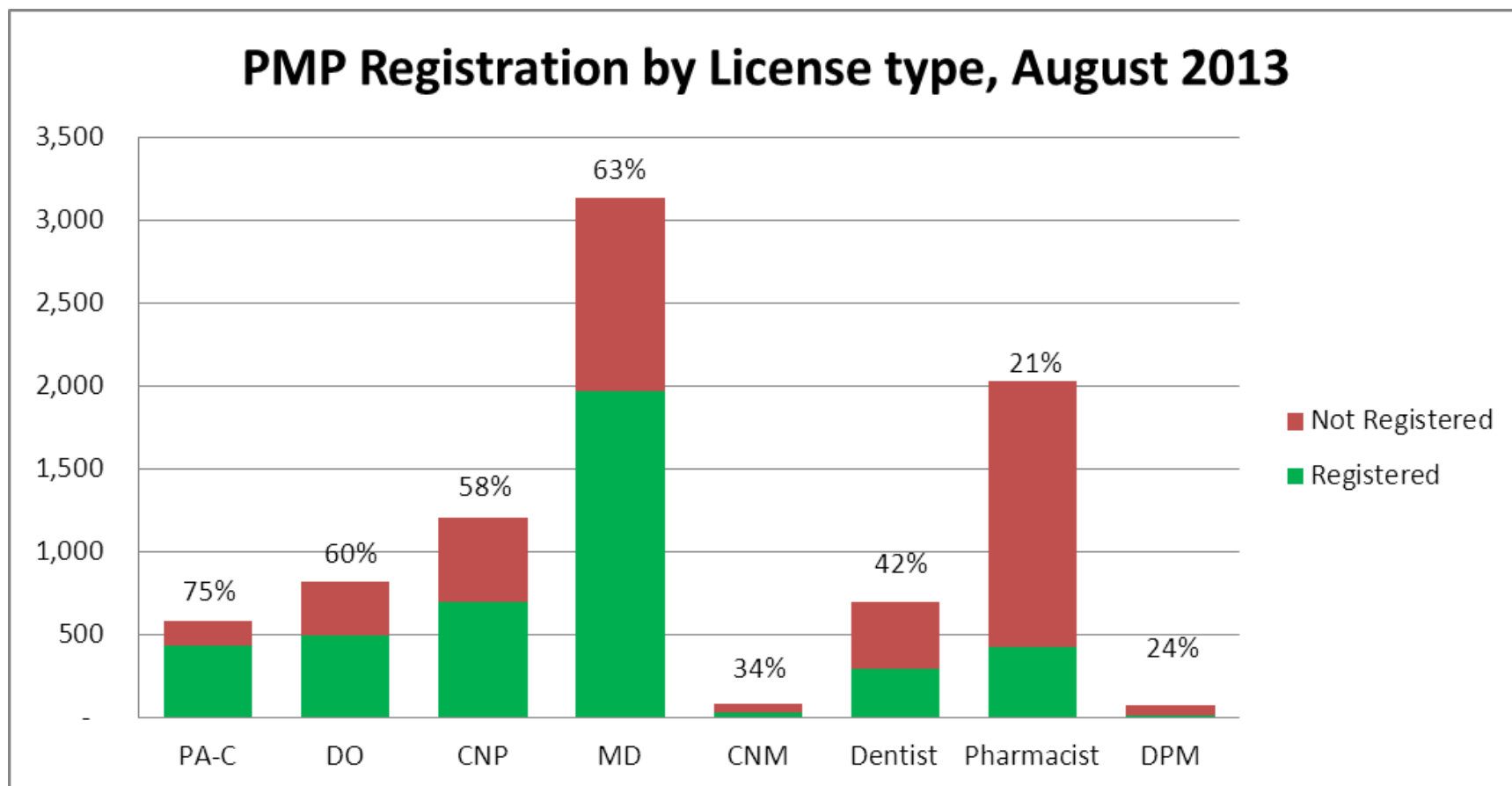


# ME PMP Prescriber registration August 2013

# PMP Reporting Requirements

## Chapter 1603: CONTROLLED SUBSTANCES PRESCRIPTION MONITORING HEADING: PL 2003, C. 483, §1 (NEW)

### §7249. Reporting of prescription monitoring information

**5. Participation requirements.** If less than 90% of the prescribers in a class of prescribers described in paragraphs A to F are registered in the program on January 1, 2014, then all the members of that class of prescribers shall register in the program by March 1, 2014. The following are the classes of prescribers that are subject to the provisions of this subsection:

- A. Allopathic physicians licensed pursuant to Title 32, chapter 48, subchapter 2; [2011, c. 477, Pt. K, §1 (NEW).]
- B. Osteopathic physicians licensed pursuant to Title 32, chapter 36; [2011, c. 477, Pt. K, §1 (NEW).]
- C. Dentists licensed pursuant to Title 32, chapter 16, subchapter 3; [2011, c. 477, Pt. K, §1 (NEW).]
- D. Physician assistants licensed pursuant to Title 32, chapter 48, subchapter 2; [2011, c. 477, Pt. K, §1 (NEW).]
- E. Podiatrists licensed pursuant to Title 32, chapter 51; and [2011, c. 477, Pt. K, §1 (NEW).]
- F. Advanced practice registered nurses licensed pursuant to Title 32, chapter 31, subchapter 3. [2011, c. 477, Pt. K, §1 (NEW).]

# LD388

- **An Act To Amend the Controlled Substances Prescription Monitoring Program Participation Requirements**
  - **Substance Abuse Services Commission**
    - Assigned the PMP to work with the Maine licensing boards to develop an online registration portal.

# LD 1014

- **An Act To Improve Law Enforcement Access to Prescription Monitoring Program Data**
- **Possible option**
  - A new PMP data request form for active LE investigations involving prescribed drugs that would require two LE signatures and a review from either the Attorney General or District Attorney.
- **The Bill Failed**

# PMP Rule Making Change

- Pharmacies must currently upload data within seven (7) days of dispensing
- Paperwork has been submitted to the Maine Secretary of States Office to make a change in rule that dispensers must upload data within 24 hours of dispensing

# Unsolicited Threshold Reports

- Enhancement for Prescribers that will offer more options for customized notifications when certain limits are reached
- Does not replace current standard threshold limits
- Customizable Limits
  - Number of Prescribers/Pharmacies visited
  - Drug Combinations/Dosage
  - Frequency of reporting

# PMP Pharmacist/Provider Redesign

- New Look and Feel for the PMP provider/pharmacist web portal
- Enhancements for the PMP web portal
  - Electronic password recovery
  - Electronic account changes
  - Electronic use audit reports
    - Providers and sub-accounts

# Online Tutorial Update



- A PMP online tutorial update later this fall
  - Detailed query walk-throughs
  - Screen shots

# Cross Promote other programs

- Work to assist promotion of safe Drug Disposal
  - Provide contact information
  - Provide information about the research and a list of disposal locations
  - Include time for drug disposal in our education and outreach programs
  - Cross Promote Drug Disposal

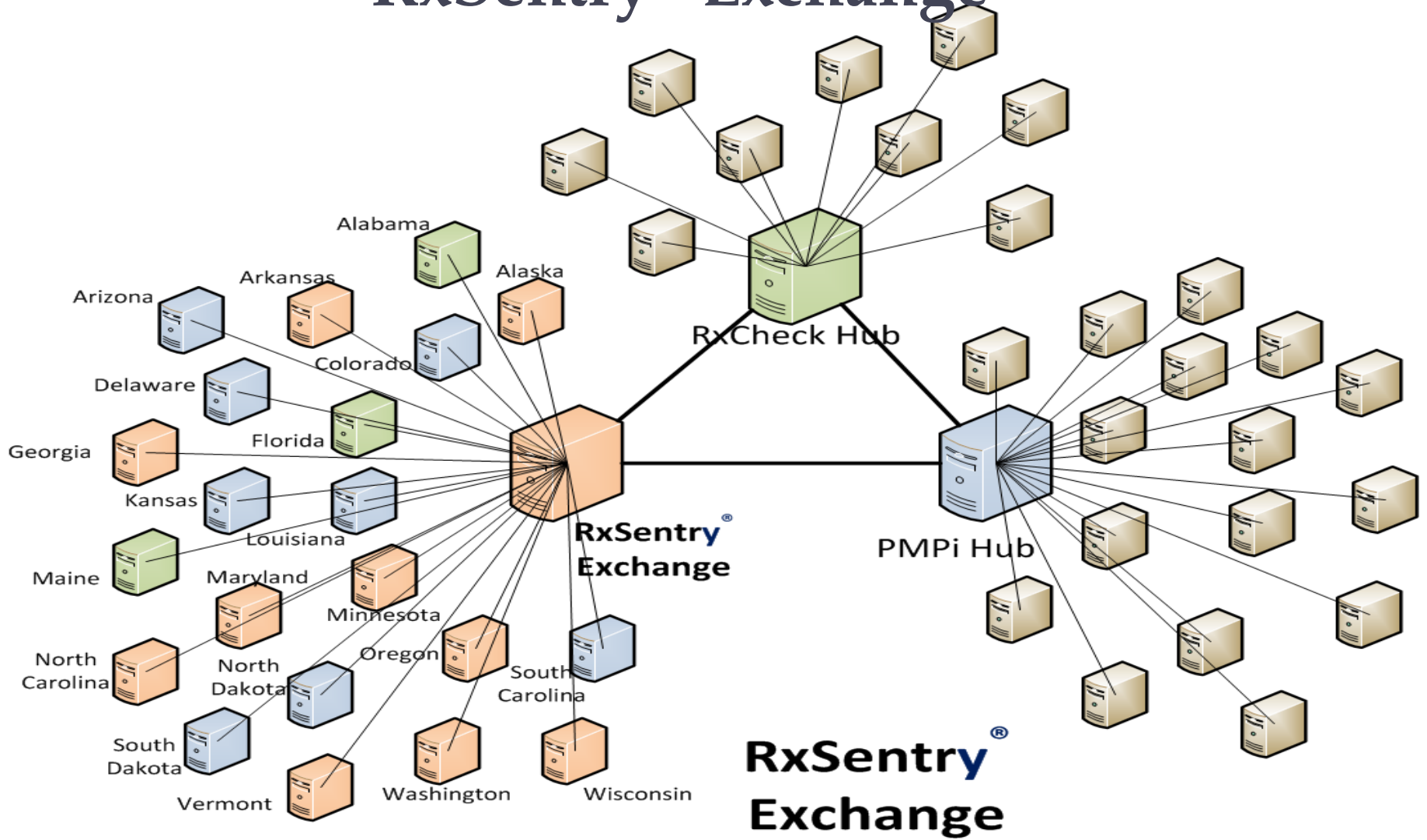

# HIE/PMP Single-Sign On

**Allow healthcare providers to go directly from HIE patient record to the PMP data.**

- By pass log-in process = less clicks
- Must be registered with both HIN & PMP
- Timeline to go live in October 2013

# PMP Pharmacy Compliance

- All Maine licensed pharmacies are required to upload Scheduled II, III & IV drugs weekly.
- Regardless of whether any controlled substances were dispensed. (Zero Reporting)
- Waivers may be granted

# Waiver Policy

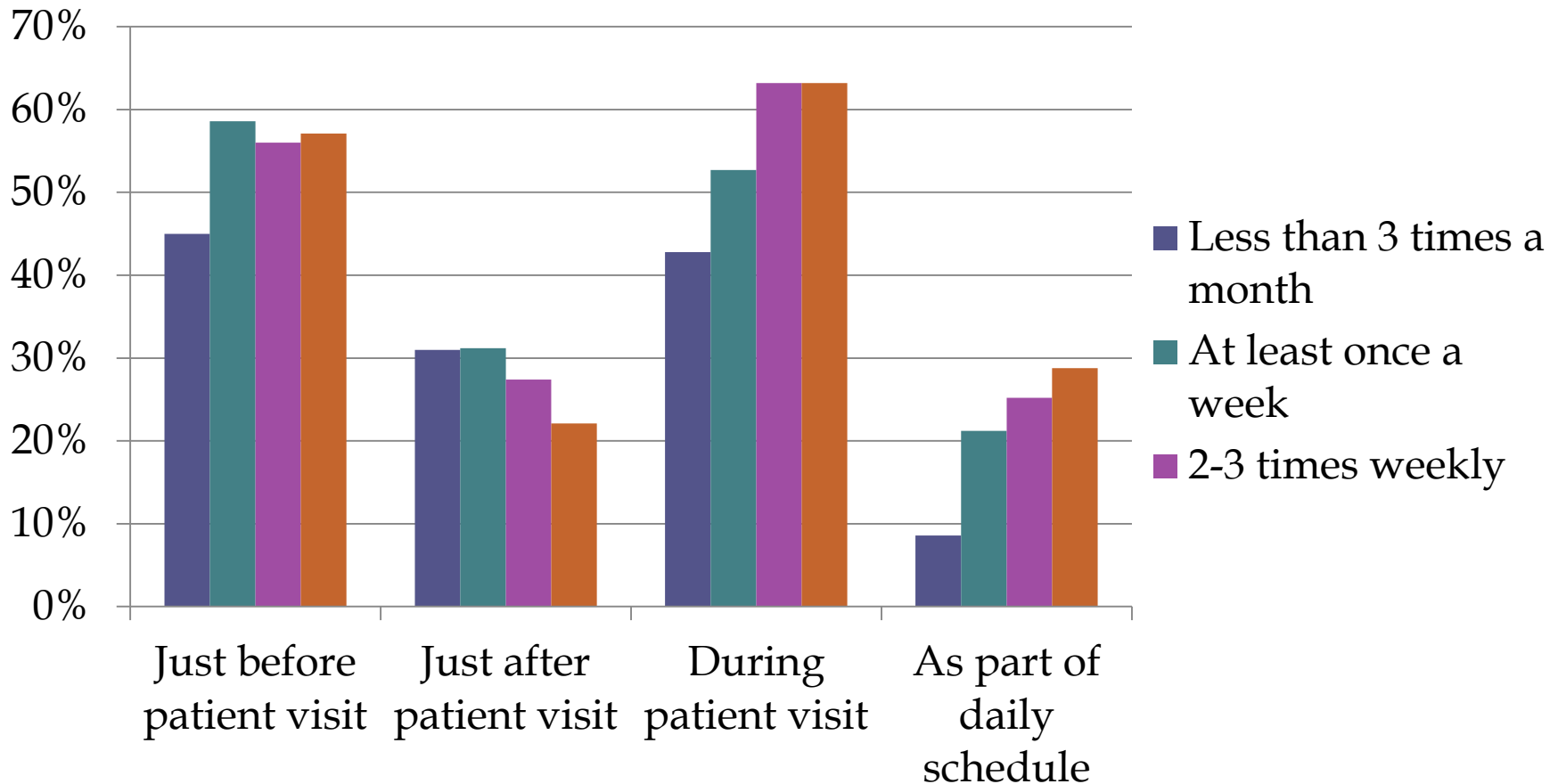
**Pharmacies may apply for a waiver from electronic submission under the following circumstances:**

- The volume is so low, financial hardship will result.
- The pharmacy does not currently deliver and/or dispense any scheduled drugs.
- Or for any other good cause identified by the pharmacy.

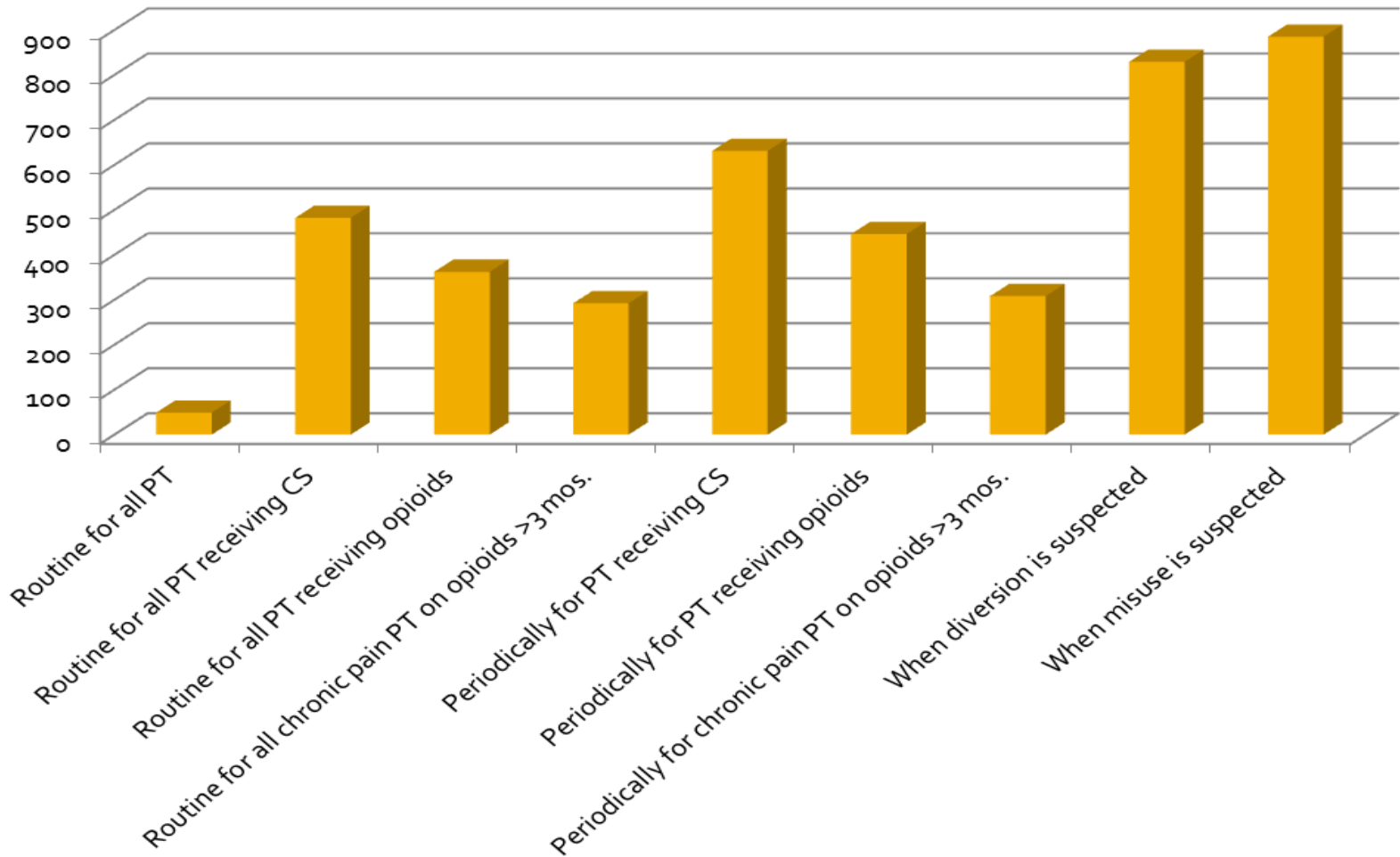
# 2013 Prescription Monitoring Program Survey Results



# PMP 2013 Survey Frequency of Use

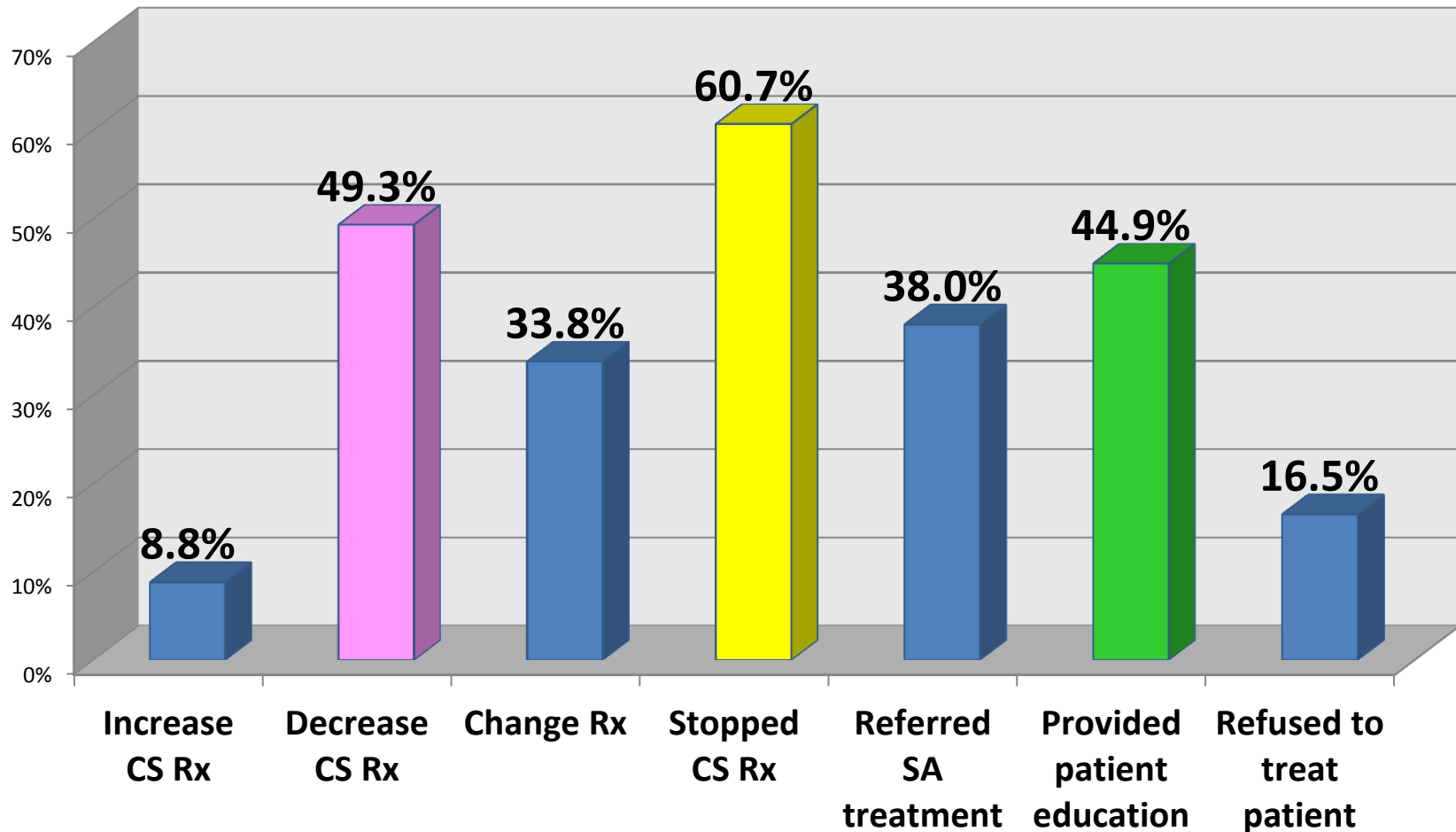


## 2013 Survey: How Respondents Use PMP
