Release of Summative Spring 2023 Maine Through Year Assessment Data

Spring 2023 Maine Through Year Assessment results data will be available according to the following timeline:

- **Thursday, September 28**: The complete Student Score Data File, containing both Maine-specific scaled scores and RIT scores, is available in Operational Reports. This is a csv file.
- Monday, October 2: Access to the Online Reporting System with both aggregated reports and Individual Student Reports becomes available.

At this time, the Student Scores tab is no longer visible in Acacia as it was not functional. The Student Scores tab will reappear on October 2 when access to the Online Reporting System opens.

NAEP 2024

SAUs and schools selected for NAEP 2024 were notified over the summer. The National Center of Education Statistics has a long-term goal of remotely administering NAEP assessments through a device agnostic platform. This transition began through field trials conducted during the spring of 2023. For the NAEP 2024 administration, students throughout Maine will participate in NAEP assessments. Each selected student will take an assessment in one subject on a NAEP-owned device such as a Chromebook or Microsoft Surface Pro tablet. The NAEP Assessment Teams will bring all of the devices and provide the staff or administration of the assessment. One change of great importance is that this year NAEP will ask to use school-based Internet, when possible, to conduct the assessment. Each selected school will be asked to designate an Onsite Technology Coordinator to provide information about the school's internet and conduct the necessary steps for the secure administration of NAEP. NAEP field staff will work with districts and schools to determine if this is feasible for each selected school.

**Please advise all principals and DACs to be on the lookout for an upcoming survey related to designating a School Coordinator for the Assessment as well as an Onsite Technology Coordinator. The survey will link will be provided in an email communication containing more details about the NAEP 2024 administration. **

September NAEP Nugget: The NAEP Assessment Management System (AMS) has been completely redesigned. As you work through the preparatory steps for the upcoming administration, please provide feedback about what is and what is not working.
