Procurement Review Report West Bath School Nutrition Program SY 2024

A review of the West Bath School Nutrition Department procurement practices from SY2023 was conducted to ensure compliance with Federal Regulations 2 CFR 200, 7 CFR 210, as well as applicable local laws.

<u>Code of Conduct</u>- No findings.

<u>Procurement Procedures</u>- Policy DJ-R – Federal Procurement Manual was reviewed. It was not compliant with 2 CFR 200.318 by exempting federal child nutrition programs (see #4 & #5 under section I. Exceptions to These Administrative). Federal child nutrition programs are required to follow the procurement regulations outlined in this manual.

Required Corrective Action – Revise policy DJ-R by removing the exemption of Child Nutrition Programs from following these federal procurement procedures.

Due Date – Complete

Micro-Purchases - No findings.

<u>Small Purchases</u>- When making small or "informal" purchases, Federal law requires that at least two price quotes from suppliers be requested and documented and the purchase made from the lowest price from a responsible bidder. The program did not obtain price quotes or maintain documentation to support the purchasing from one prime vendor.

Required Corrective Action- Compare delivery and pricing information from at least two different vendors. Submit documentation of the solicitation and justification for purchasing from the selected vendor.
