Re: Notification of Data Security Incident

Dear Attorney General Frey:

Constangy, Brooks, Smith & Prophete, LLP represents the American Meteorological Society ("AMS"), a scientific and professional organization that promotes and disseminates information about the atmospheric, oceanic, and hydrologic sciences headquartered in Boston, Massachusetts, in conjunction with a recent data security incident described in greater detail below. The purpose of this letter is to notify you of the incident in accordance with Maine's data breach notification law.

1. Nature of the Security Incident

AMS learned on December 5, 2023 that personal information was involved in a data security incident. AMS became aware of suspicious activity within its network environment on April 24, 2023. AMS immediately took steps to secure the network environment and engaged a cybersecurity firm to conduct an investigation. The investigation determined that an unknown actor gained unauthorized access to and may have obtained data from the AMS's network on or about April 20, 2023. AMS subsequently engaged data mining experts to conduct a comprehensive review of the affected files to determine whether they contained personal information belonging to individuals. After a thorough investigation, on December 5, 2023, AMS determined that certain personal information was involved in the incident and worked diligently to notify these individuals.

2. Type of Information and Number of Maine Residents Affected

AMS is notifying five (5) residents of Maine of this data security incident via first class U.S. mail on December 14, 2023. The information accessed and potentially acquired by the unauthorized actor responsible for this incident may have included name and Social Security number, driver's license

or state identification number, medical information, and health insurance information. A sample copy of the notification letter sent to these individuals is included with this correspondence.

3. Steps Taken Relating to the Incident

In response to this incident, AMS implemented additional security features in an effort to prevent a similar incident from occurring in the future. Further, as referenced below AMS has offered all individuals whose information was involved 12 months of complimentary services through IDX, which includes credit monitoring, dark web monitoring, a \$1 million identity fraud loss reimbursement policy, fully-managed identity theft recovery services, and 90 days access to a call center.



We are writing to inform you of a data security incident that may have involved your personal information. The American Meteorological Society ("AMS") takes the privacy and security of personal information very seriously. This is why we are notifying you of the incident, providing you with steps you can take to help protect your personal information, and offering you the opportunity to enroll in complimentary credit monitoring and identity protection services.

What Happened? On December 5, 2023, we learned that your information may have been involved in a cyber incident. In April this year, we experienced a cyber incident in which an unauthorized person obtained access to our system. We immediately took steps to secure our network environment and launched an investigation to find out what happened. The investigation revealed that the unauthorized person may have obtained data from our network. We then searched that data and to determine whose information might have been involved. While we do not know that your information was accessed by anyone, out of an abundance of caution, we are providing you with this notification and the opportunity to enroll in complimentary identity monitoring.

What Information Was Involved? The information involved may include your name and your <<Variable Text 2: PI involved>>.

What We Are Doing. As soon as we discovered the incident, we took the steps referenced above. We also implemented additional security features to reduce the risk of a similar incident occurring in the future. We notified federal law enforcement and will provide whatever cooperation is necessary to hold the perpetrators accountable. Additionally, AMS is offering you complimentary credit monitoring and identity protection services for <<Variable Text 3: 12/24>> months through IDX, a national leader in identity protection services. The IDX services, which are free to you upon enrollment, include a subscription for the following: credit monitoring, CyberScan dark web monitoring, fully managed identity recovery services, and \$1 million in identity theft insurance coverage. With this protection, IDX will help you resolve issues if your identity is compromised.

What You Can Do. Please review this letter carefully, along with the guidance included with this letter about additional steps you can take to protect your information. You can also enroll in the IDX identity protection services, which are offered to you at no cost.

To receive credit monitoring services, you must be over the age of 18 and have established credit in the United States, have a Social Security number in your name, and have a U.S. residential address associated with your credit file.

To enroll in the services provided through IDX, please call 1-800-939-4170 Monday through Friday from 9:00 am – 9:00 pm Eastern Time or visit <u>https://app.idx.us/account-creation/protect</u> and insert the Enrollment Code provided above.

Please note the deadline to enroll in these complimentary services is March 14, 2024. Please do not discard this letter, as you will need the Enrollment Code provided above to access services.

ADDITIONAL STEPS YOU CAN TAKE TO FURTHER PROTECT YOUR INFORMATION

Review Your Account Statements and Notify Law Enforcement of Suspicious Activity: As a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and monitoring free credit reports closely for errors and by taking other steps appropriate to protect accounts, including promptly changing passwords. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained for remediation assistance or contact a remediation service provider. You also should promptly report any fraudulent activity or any suspected incidence of identity theft to proper law enforcement authorities, your state attorney general, and/or the Federal Trade Commission (FTC). You should also contact your local law enforcement authorities and file a police report. Obtain a copy of the police report in case you are asked to provide copies to creditors to correct your records. Contact information for the Federal Trade Commission is as follows:

Fraud Alerts: There are two kinds of general fraud alerts you can place on your credit report—an initial alert and an extended alert. You may want to consider placing either or both fraud alerts on your credit report. An initial fraud alert is free and will stay on your credit file for at least 90 days. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any accounts in your name. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and provide the appropriate documentary poof. An extended fraud alert is also free and will stay on your credit report for seven years. To place a fraud alert on your credit report, contact any of the three credit reporting agencies identified above. Additional information is available at http://www.annualcreditreport.com. Military members may also place an Active Duty Military Fraud Alert on their credit reports while deployed. An Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment

Credit or Security Freezes: Under U.S. law, you have the right to put a credit freeze, also known as a security freeze, on your credit file, for up to one year at no cost. The freeze will prevent new credit from being opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A security freeze is designed to prevent potential creditors from accessing your credit report without your consent. As a result, using a security freeze may interfere with or delay your ability to obtain credit. You must separately place a security freeze on your credit file with each credit reporting agency. There is no fee to place or lift a security freeze. For information and instructions on how to place a security freeze, contact any of the credit reporting agencies or the Federal Trade Commission identified above. In order to place a security freeze, you may be required to provide the consumer reporting agency with information that identifies you including your full name, Social Security number, date of birth, current and previous addresses, a copy of your state-issued identification card, and a recent utility bill, bank statement or insurance statement. After receiving your freeze request, each credit bureau will provide you with a unique PIN or password. Keep the PIN or password in a safe place as you will need it if you choose to lift the freeze.

A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or via phone, a credit bureau must lift the credit freeze within an hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after receiving your request.

IRS Identity Protection PIN: You can obtain an identity protection PIN (IP PIN) from the IRS that prevents someone else from filing a tax return using your Social Security number. The IP PIN is known only to you and the IRS and helps the IRS verify your identity when you file your electronic or paper tax return. You also have certain rights under the Fair Credit Reporting Act (FCRA): These rights include the right to know what is in your file; to dispute incomplete or inaccurate information; to have consumer reporting agencies correct or delete inaccurate, incomplete, or unverifiable information.
