We have no reason to believe that your personal information has been misused for the purpose of committing fraud or identity theft. What Happened? We recently learned that an unauthorized party accessed one (1) Untracht Early email account. Upon discovering the incident, we promptly secured the email account and began an internal investigation. We also engaged a forensic security firm to investigate and confirm the security of our email and computer systems. This investigation determined that the unauthorized party accessed the email account at various times beginning on or before March 25, 2022, and concluding on June 9, 2022.

What Information Was Involved? We reviewed the account's contents to determine if it contained any personal information. On August 16, 2022, we determined that the account contained your name, together with your <<vr/>variable text>>. While our review determined that this information was contained in the email account, our investigation did not find evidence confirming that the unauthorized party actually viewed the information.

What We Are Doing. In addition to the actions described above, we have taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Although we are not aware of any instances of fraud or identity theft involving your personal information, we are offering a complimentary one-year membership of Experian IdentityWorksSM Credit 3B.
