

# **EXHIBIT 1**

This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, BankCard USA does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

On June 1, 2023, BankCard USA discovered suspicious activity relating to their computer systems. They immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. The investigation determined that files on certain computer systems were subject to unauthorized access and acquisition between May 31, 2023 and June 1, 2023. BankCard USA began reviewing the affected systems to determine what, if any, sensitive information was contained within the systems in question. On July 14, 2023, BankCard USA confirmed the scope of that the information that could have been subject to unauthorized access includes name, Social Security number and financial account information of thirty-two (32) Maine residents.

### **Notice to Maine Residents**

On August 16, 2023, BankCard USA provided written notice of this incident to thirty-two (32) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, BankCard USA moved quickly to investigate and respond to the incident, assess the security of BankCard USA systems, and identify potentially affected individuals. Further, BankCard USA notified federal law enforcement regarding the event. BankCard USA is also working to implement additional safeguards and training to its employees. BankCard USA is providing access to credit monitoring services for twenty-four (24) months, through Equifax, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, BankCard USA is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. BankCard USA is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. BankCard USA is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

BankCard USA Merchant Services Inc. (“BankCard”) is writing to inform you of an incident that has impacted the security of some of your information. Although we have no indication of actual fraud or misuse of your information, we are providing you with information about the incident, our response to it, and resources available to you to help protect your information, should you feel it appropriate to do so.

**What Happened?** On June 1, 2023, we discovered suspicious activity relating to our computer systems. We immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. Our investigation determined that files on certain computer systems were subject to unauthorized access and acquisition by an unauthorized party between May 31, 2023 and June 1, 2023. BankCard began reviewing the affected systems to determine what, if any, sensitive information was contained within the systems in question. On July 14, 2023, BankCard confirmed certain information related to you was contained within the files. We are notifying you and providing information about the incident, and resources to help protect your personal information.

**What Information Was Involved?** The following types of your information were identified in the files: your name and <<Consolidated Breached Elements>>.

**What We Are Doing.** BankCard takes the confidentiality, privacy, and security of information in our care very seriously. Upon discovery, BankCard immediately commenced an investigation to confirm the nature and scope of the incident. BankCard reported this incident to law enforcement, has implemented additional layers of security in our identification and verification processes, and is taking steps to implement additional safeguards and review policies and procedures relating to data privacy and security. As an added precaution, we are also offering you complimentary access to 24 months of credit monitoring and identity theft restoration services, through Equifax. You will need to enroll yourself in these services if you wish to do so, as we are not able to activate them on your behalf. Please review the instructions contained in the attached *Steps You Can Take to Help Protect Your Information* for additional information on these services.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You may also review the information contained in the enclosed *Steps You Can Take to Help Protect Your Information*. There you will also find more information on the credit monitoring and identity restoration services we are making available to you. While BankCard will cover the cost of these services, you will need to complete the activation process. Enrollment instructions are included in this letter.

## STEPS YOU CAN TAKE TO PROTECT YOUR INFORMATION

### Enroll in Monitoring Services

#### Equifax Credit Watch™ Gold

\*Note: You must be over age 18 with a credit file to take advantage of the product

#### Key Features

- Credit monitoring with email notifications of key changes to your Equifax credit report
- Daily access to your Equifax credit report

#### Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
