RE: NOTICE OF DATA BREACH

Fortera Credit Union ("Fortera") respects the privacy of your information, which is why we are writing to advise you of a recent incident that may have involved some of your personal information.

What Happened? We recently learned that someone gained access to a Fortera email account for a very short time on January 14, 2021 and used the account to send spam emails. While we have no evidence that your personal information has been misused, you can find more information on steps to protect yourself against identity theft or fraud in the enclosed *Additional Important Information* sheet.

What Information Was Involved? On April 20, 2021, we determined that the account contained personal information that included your name and Social Security number.

What We Are Doing. Upon discovering the incident, we promptly controlled the incident by preventing any further access to the email account. We also engaged a forensic security firm to investigate and confirm the security of our email and computer systems. We have taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures.

What You Can Do. Although we are not aware of any instances of fraud or identity theft, we are offering a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. <u>Fraud Alerts:</u> You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze can be placed without any charge and is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
