Dear :

The protection and privacy of your personal information is one of Mudd & Moreland, LLC's highest priorities. Because of this, we are writing to make you aware of a recent data security incident that may have involved some of your information. We have no reason to believe that your personal information has been misused for the purpose of committing fraud or identity theft. Nonetheless, we are writing to advise you about the incident and to provide you with guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

What Happened? We recently became aware that an employee email account was temporarily accessed without authorization. Upon detection, we promptly contained the incident by securing the account to prevent further access. We also engaged a leading forensic firm to determine the scope of the incident and confirm the security of our systems. We have no reason to believe that the attacker was looking for personal information, and we do not know if any information was ever actually viewed or acquired by the attacker. Nevertheless, because the bad actor had temporary access to the email account, we searched for any personal information in the account that could have been viewed. On September 2, 2021, we determined that the account contained some of your personal information could have been viewed for a period of time on June 20, 2021.

**What Information Was Involved?** The type of information in the account differs from individual to individual, but it included your name, Social Security number and date of birth.

What We Are Doing. In addition to the actions described above, we have also taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Also, out of an abundance of caution, we are offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. <u>Credit and Security Freezes</u>: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
