The investigation into this matter is ongoing, and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Pavese, Haverfield, Dalton, Harrison, & Jensen LLP d/b/a Pavese Law Firm ("Pavese Law Firm") does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about September 18, 2021, Pavese Law Firm became aware of suspicious activity relating to certain systems, including the encryption of files. Upon discovery, Pavese Law Firm engaged our law firm to investigate the nature and scope of the activity. The investigation determined that certain systems containing personal information within Pavese Law Firm's network were accessed by an unauthorized actor. In response, Pavese Law Firm began a deliberate and thorough assessment of the information potentially impacted during this event and to whom that information pertained. On or about April 20, 2022, we confirmed that files containing the name, Social Security number, and driver's license number for one (1) Maine resident could have been subject to unauthorized access.

Notice to Maine Resident

On May 19, 2022, Pavese Law Firm provided written notice of this incident to one (1) Maine resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Pavese Law Firm moved quickly to investigate and respond to the incident, assess the security of Pavese Law Firm systems, and identify potentially affected individuals. Further, Pavese Law Firm notified federal law enforcement regarding the event. Pavese Law Firm is also working to implement additional safeguards and training to its employees. Pavese Law Firm is providing access to credit monitoring services for two (2) years, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Pavese Law Firm is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Pavese Law Firm is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Pavese Law Firm takes the protection of your information very seriously and this letter provides details regarding the incident, our response, and access to resources so that you can protect your personal information, should you feel it is appropriate to do so. We also are offering you 24 months of complimentary credit and fraud monitoring, with \$1,000,000 in identity theft insurance; enrollment instructions can be found in the following pages.

What Happened? On September 18, 2021, Pavese Law Firm learned that it was the victim of a criminal cyberattack. We promptly took steps to secure our systems and commenced an investigation into the nature and scope of the incident. We have been working diligently to determine what may have happened and what information may have been affected. While the investigation was able to confirm that certain systems were accessed by the criminal actor, we have been unable to determine exactly what information was impacted. Therefore, in an abundance of caution, Pavese Law Firm conducted an extensive review of the entire contents of the impacted systems, and on April 20, 2022, Pavese Law Firm's investigation confirmed that the potentially impacted data included certain information relating to you.

What Information Was Involved? While we have been unable to determine exactly what information was impacted, we are providing you this notification out of an abundance of caution because certain information relating to you was contained on systems that were accessed during this event. The potentially impacted information relating to you includes your [Extra1].

What We Are Doing. The privacy and security of information are among one of our highest priorities and Pavese Law Firm has measures in place to protect information in our care. Upon discovering this incident, we immediately took steps to secure the environment and to conduct an investigation with the assistance of third-party professionals to determine the scope of any unauthorized access to legally protected information. We also commenced a review of existing security policies and are implementing additional measures and enhanced security tools to further protect information in our systems. We are also implementing additional safeguards and are providing additional training to our

employees on data privacy and security. We have also reported this incident to law enforcement, and will participate with any criminal investigation into this matter. Finally, we are offering you 24 months of complimentary credit and fraud monitoring, with \$1,000,000 in identity theft insurance; enrollment instructions can be found in the following pages.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements, and to monitor your credit reports for suspicious activity. You may review the information contained in the attached "Steps You Can Take to Protect Personal Information." You may also enroll to receive the identity protection services we are making available to you. There is no charge to you for the cost of this service; however, you will need to enroll yourself in this service.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before



extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security Number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

Internal Revenue Service Identity Protection PIN (IP PIN)

The IP PIN is known only to you and the IRS, and helps the IRS verify your identity when you file your electronic or paper tax return. Even though you may not have a filing requirement, an IP PIN still protects your account.
