This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, NOW Health Group, Inc. ("NOW") located at 244 Knollwood Dr., Bloomingdale, IL 60108, does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

#### Nature of the Data Event

On or about March 17, 2023, NOW discovered suspicious activity in its email environment. Upon learning this, NOW immediately launched an investigation to determine the nature and scope of the activity, and secured the involved email accounts. The investigation determined that there was unauthorized access to certain employee email accounts between March 17, 2023 and March 20, 2023 and information stored in the accounts could have been accessed and/or acquired without authorization. NOW then undertook a comprehensive review of the contents of the accessed email accounts to identify whether they contained any sensitive information and to whom the information relates. On July 6, 2023, this detailed review was complete, and NOW determined certain information related to a Maine resident was impacted by this incident. NOW continued working since this time to further review and validate the nature of the information at issue for each person in order to make the appropriate notifications.

The information that could have been subject to unauthorized access varies for each person, but includes name and Social Security number.

### Notice to Maine Resident

On or about September 5, 2023, NOW provided written notice of this incident to one (1) Maine resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit* A.


## Other Steps Taken and To Be Taken

Upon discovering the event, NOW moved quickly to investigate and respond to the incident, secure the impacted email accounts, and identify potentially affected individuals. NOW is also working to implement additional safeguards and training to its employees to help prevent similar future incidents. NOW is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, NOW is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. NOW is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

NOW is providing written notice of this incident to relevant state and federal regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion. NOW is also notifying the U.S. Department of Health and Human Services pursuant to the Health Insurance Portability and Accountability Act (HIPAA).

NOW Health Group, Inc. ("NOW") writes to notify you of an incident that may affect the privacy of some of your information. This letter provides details of the incident, our response, and steps you may take to better protect against the possible misuse of your information, should you wish to do so.

**What Happened?** On or about March 17, 2023, NOW discovered suspicious activity in our email environment. Upon learning this, we immediately launched an investigation to determine the nature and scope of the activity, and secured the involved email accounts. The investigation determined that there was unauthorized access to certain employee email accounts between March 17, 2023 and March 20, 2023 and information stored in the accounts could have been accessed and/or acquired without authorization. We then undertook a comprehensive review of the contents of the accessed email accounts to identify whether they contained any sensitive information and to whom it relates. On July 6, 2023, this detailed review was complete, and we determined certain information related to you was impacted by this incident. We have worked since this time to further review and validate the nature of the information at issue for each person in order to make the appropriate notifications.

**What Information Was Involved?** NOW determined the information located in the accessed email accounts relating to you includes the following information: your name, [Extra1]. While we were unable to confirm whether email messages containing your information were actually opened or viewed without authorization, we are providing notice to you as your information was present within one or more of the accessed email accounts, and we cannot rule out this possibility.

What We Are Doing. NOW takes the confidentiality, privacy, and security of information in our care seriously. Upon discovery of the incident, we immediately commenced an investigation to determine what happened, secured the impacted accounts, and took steps to implement additional safeguards and review our policies and procedures relating to data privacy and security.

While we have no evidence of any fraud or misuse of anyone's information in connection with this incident, in an abundance of caution, NOW is providing you with access to twelve (12) months of credit monitoring and identity protection services through Experian at no cost to you. A description of the services and instructions on how to enroll can be found within the enclosed *Steps You Can Take to Protect Personal Information*. Please note that you must complete the enrollment process yourself as we are not permitted to enroll you in these services.



What You Can Do. You can review the enclosed *Steps You Can Take to Protect Personal Information* for general guidance. In addition, you can enroll in the complimentary credit monitoring and identity protection services being offered through Experian. We also encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity.

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you may need to provide some of the following information, depending on whether the request is made online, by phone, or by mail:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
