Dow Credit Union values and respects the privacy of your information, which is why we are writing to advise you of a recent incident at one of our service providers that involved some of your information. This letter explains the incident, steps we have taken in response, and things you can do to help protect yourself, should you feel it is appropriate to do so.

What Happened? MOVEit is a popular file transfer service used by government agencies, corporations, financial institutions, healthcare providers, and other organizations around the world. At the end of May 2023, unauthorized third parties began exploiting a previously unknown vulnerability in MOVEit that allowed the third parties to gain access to files on MOVEit systems. On August 8, 2023, we learned that one of our service providers was impacted by the MOVEit incident, and that certain files the service provider maintains were subject to unauthorized access. For clarity, this third-party incident was external to Dow Credit Union. The unauthorized parties did not gain access to any Dow Credit Union computers or other Dow Credit Union systems.

What Information Was Involved? Upon learning of the incident at our service provider, we promptly began an investigation and worked closely with our service provider to understand what files were involved. On August 11, 2023, we determined that the files contained your name, mailing address, Social Security number, account number, account balance, and date of birth.

What We Are Doing. Although we are not aware of any instances of fraud or identity theft involving your information, in an abundance of caution, we are offering you a complimentary one-year membership of Experian IdentityWorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter. Additionally, we are reviewing our relationship with the involved service provider and evaluating ways to reduce the risk of a similar incident occurring in the future.

What You Can Do. While we have no evidence that your personal information has been misused, we encourage you to take advantage of the complimentary credit monitoring included in this letter. You can find more information on steps to protect yourself against possible identity theft or fraud in the enclosed *Additional Important Information* sheet.

Additional Important Information

As a precautionary measure, we recommend that you remain vigilant to protect against potential fraud and/or identity theft by, among other things, reviewing your account statements and monitoring credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You should also promptly report any fraudulent activity or any suspected incidents of identity theft to proper law enforcement authorities, including the police and your state's attorney general, as well as the Federal Trade Commission ("FTC").

Fraud Alerts: You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. <u>Credit and Security Freezes</u>: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze can be placed without any charge and is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
