The investigation into this matter is ongoing, and this notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Butte SD does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On or about November 4, 2023, Butte SD became aware of suspicious activity on its computer network. Butte SD immediately launched an investigation, with the assistance of cyber incident response specialists, to determine the nature and scope of the activity. The investigation determined that an unauthorized actor gained access to Butte SD's network on November 4, 2023, and copied a limited number of files containing information related to current and former Butte SD employees. In response, Butte SD undertook a thorough review of the impacted files to identify individuals whose information was present therein and quickly identified that personal information related to current and former 8, 2023, determined that information related to Maine residents was present in the impacted files. Butte SD then proceeded with notification to its potentially affected current and former Butte SD employees, out of an abundance of caution, while continuing to review potentially affected files to identify whether any additional individuals require notification. This report will be updated if additional impacted Maine residents are identified in the course of same.

The information that could have been subject to unauthorized access includes name, Social Security number and, for certain individuals, personal bank account information.

Notice to Maine Residents

On or about December 19, 2023, Butte SD provided written notice of this incident to two (2) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit* A.

Other Steps Taken and To Be Taken

Upon discovering the event, Butte SD moved quickly to investigate and respond to the incident, assess the security of Butte SD systems, and identify potentially affected individuals. Further, Butte SD notified federal law enforcement regarding the event. Butte SD is also working to implement additional safeguards and training to its employees. Butte SD is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Butte SD is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Butte SD is also providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state attorney general, and law enforcement to report attempted or actual identity theft and fraud.

Butte SD is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

Butte School District ("Butte SD") is writing to inform you of a recent incident that may involve some of your information. We are providing you with information about the event, our response, and steps you may take to better protect against the possibility of identity theft and fraud, should you feel it is appropriate to do so.

What Happened? On or about November 4, 2023, Butte SD became aware of suspicious activity on our computer network. We immediately launched an investigation, with the assistance of cyber incident response specialists, to determine the nature and scope of the activity. Our investigation learned that an unauthorized actor gained access to our network on November 4, 2023 and copied certain files containing information related to current and former Butte SD employees.

What Information Was Involved? Our review to date of the involved files indicates that the following types of current employee information may have been impacted: name, address, date of birth, Social Security number and, to the extent you utilized direct deposit for your paycheck while employed by Butte SD, personal bank account information.

What We Are Doing. We want to assure you that the privacy and security of information in our care is one of our top priorities. Upon learning of the event, we immediately took steps to secure our systems and conducted an investigation to confirm the nature and scope of the activity and determine who may be affected. Additionally, while we have safeguards in place to protect data in our care, we are working to review and further enhance these protections as part of our ongoing commitment to data security. We also reported this event to federal law enforcement and government regulators.

As an added precaution, we are also offering you 12 months of credit monitoring and identity restoration services at no cost to you through Experian. Details of the services offered and instructions on how to enroll are enclosed with this letter.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your credit reports for suspicious activity and to detect errors. Please review the enclosed *Steps You May Take to Help Protect Personal Information* for useful information on what you can do to better protect against possible misuse of your information. You may also enroll in the free credit monitoring services we have provided for you.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
