However, a review of the contents of the files was conducted to determine whether sensitive information was present in the affected files at the time of the incident.

Treeways provided initial notice of this event on June 16, 2023. Treeways then continued an extensive and time intensive search to identify address information for the potentially impacted individuals. This search recently concluded and Treeways moved quickly to provide additional notice to affected individuals.

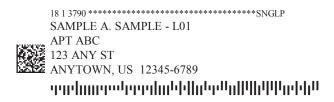

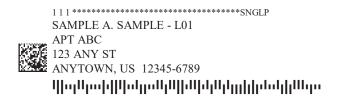

To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
