By providing this notice, Berkshire Farm Center & Services for Youth ("Berkshire") does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On July 15, 2022, Berkshire learned of suspicious activity impacting certain servers. Upon learning of the suspicious activity, Berkshire promptly took steps to secure its systems and launched an investigation, with the assistance of third-party cyber security specialists, to determine the nature and scope of the activity. The forensic investigation determined that certain files within its systems were accessed by an unauthorized actor. After learning that certain files within its systems were accessed by an unauthorized actor, Berkshire conducted an in-depth and comprehensive review of the files to determine what information was contained within, and to whom the information relates. Once this extensive review concluded, Berkshire then undertook an extensive and comprehensive review to identify appropriate contact information for potentially affected individuals so to provide written notice.

The information that could have been subject to unauthorized access includes name and financial account information.

Notice to Maine Residents

On February 28, 2023, Berkshire provided written notice of this incident to two (2) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

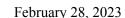
Other Steps Taken and To Be Taken

Upon discovering the event, Berkshire moved quickly to investigate and respond to the incident, assess the security of Berkshire systems, and identify potentially affected individuals. Further, Berkshire notified federal law enforcement regarding the event. Berkshire is also working to implement additional safeguards and training to its employees. Berkshire is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Berkshire is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Berkshire is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Berkshire is providing notice of this incident to relevant state and federal regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion. Berkshire also notified law enforcement of this incident.

Berkshire Farm Center & Services for Youth ("Berkshire") writes to inform you of a recent event that may have affected some of your personal information. Although there is no indication that your personal information was misused as a result of the event, we are providing you with information about the event, our response to it, and resources available to you to help protect your information, should you feel it appropriate to do so.

What Happened? On July 15, 2022, Berkshire learned of suspicious activity impacting certain servers. Upon learning of the suspicious activity, we promptly took steps to secure our systems and launched an investigation, with the assistance of third-party cyber security specialists, to determine the nature and scope of the event. Our investigation determined that certain files within our systems were accessed by an unauthorized actor.

After learning that certain files within our systems were accessed by an unauthorized actor, we conducted an indepth and comprehensive review of the files to determine what information was contained within, and to whom the information relates. Once this extensive review concluded, we then undertook an extensive and comprehensive review to identify appropriate contact information for potentially affected individuals to provide written notice. We are notifying you because the investigation determined certain information relating to you, as a current or former employee of Berkshire, may have been accessed by the unauthorized actor.

What Information Was Involved? The information that may have been viewed as a result of the event includes your name, address, and financial account information. At this time, we have no indication that your information was subject to actual or attempted misuse as a result of the event.

What We Are Doing. The confidentiality, privacy, and security of information within our care is among Berkshire's highest priorities. Upon learning of the event, we promptly launched an investigation with the assistance of third-party cyber security specialists to confirm the nature and scope of the event. Although we had policies and procedures surrounding data security in place at the time of the incident, as part of our ongoing commitment to the security of information, we are also reviewing and improving existing policies and procedures. We also notified regulatory authorities, as required by law. Additionally, we notified law enforcement and are actively cooperating with its investigation.

As an added precaution, we are also offering you access to [Extra2] months of complimentary credit monitoring services through Experian. Individuals who wish to receive these services must enroll by following the attached enrollment instructions.

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, explanation of benefits, and credit reports for suspicious activity over the next 12 to 24 months. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
