## To Whom It May Concern:

Dollar Energy Fund ("DEF") located at 15 Terminal Way, Pittsburgh, PA 15219, writes to provide notification of a recent data breach. DEF is a 501(c)(3) organization whose mission is to improve the quality of life for households experiencing hardship by providing utility assistance and other services that lead to self-sufficiency. DEF works with its utility company partners to provide these important services. By providing this notice, DEF does not waive any rights or defenses under Maine law, including the data breach notification statute.

On February 5, 2023, DEF experienced a network disruption and immediately began an investigation, which included working with third-party specialists. The investigation determined that certain information stored on DEF's network was accessed by an unauthorized third-party between January 31, 2023 and February 5, 2023. Therefore, DEF engaged an additional vendor to assist in the review of potentially affected information.

On August 15, 2023, DEF completed its review and began confirming address information for potentially impacted individuals. The type of personal information involved included name and Social Security number. DEF identified approximately two Maine residents who may have been impacted by this incident. Beginning on August 23, 2023, DEF notified its affected utility company partners of this incident.

DEF conducted individual notice on a rolling basis as its utility company partners approved the notices. On September 28, 2023, DEF began providing written notice to the potentially impacted individuals via U.S. mail, and DEF completed mailing individual notices on October 19, 2023. A copy of the notice is attached as *Exhibit A*. In an abundance of caution, DEF is offering the potentially impacted individuals complimentary credit monitoring and identity protection services. Additionally, in response to this incident, DEF conducted an investigation, notified the FBI, changed network passwords, and reviewed its policies and procedures related to data protection.

Dollar Energy Fund works with its partners to provide vital utility assistance and other services to families in our communities. We write to notify you of an incident that may affect the privacy of certain information provided to us. This letter includes information about the incident, our response, and resources we are making available to you.

<u>What Happened</u>: On February 5, 2023, we experienced a network disruption that impacted our ability to access certain files on our network. We immediately reported the incident to law enforcement and began working with computer specialists. Our investigation determined that certain information stored on our network was accessed between January 31, 2023 and February 5, 2023. Therefore, in an abundance of caution, we are notifying potentially impacted individuals.

#### STEPS YOU CAN TAKE TO PROTECT YOUR INFORMATION

# **Enroll in Credit Monitoring / Identity Protection**

In response to the incident, we are providing you with access to Credit Monitoring/Credit Report/Credit Score services at no charge. These services provide you with alerts for twenty-four (24) months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by Cyberscout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

To enroll credit monitoring services in at charge, please log no on to https://secure.identityforce.com/benefit/dollarenergy and follow the instructions provided. When prompted please provide the following unique code to receive services: [CODE]. In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

### **Monitor Your Accounts**

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit <a href="www.annualcreditreport.com">www.annualcreditreport.com</a> or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended fraud alert on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a credit freeze on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Address for the prior two to five years;
- 5. Proof of current address, such as a current utility or telephone bill;

- 6. A legible photocopy of a government-issued identification card (e.g., state driver's license or identification card); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.
