## Re: Notice of Data Security Incident

To Whom It May Concern:

We continue to represent The Brock Group ("Brock") and write to supplement our notice to your office dated August 10, 2021 regarding the data security incident recently experienced by Brock that may have impacted personal information belonging to Maine residents. The potentially impacted information may have included residents' names as well as residents' Social Security numbers.

As previously noted, on May 11, 2021, Brock learned of unusual activity within its digital environment. In response, Brock took immediate steps to secure its systems. On June 3, 2021, Brock then learned that an unauthorized third party had potentially gained access to certain Brock systems and that information stored on such systems may have been accessed or acquired without authorization. In early July, Brock retained independent cybersecurity experts to determine what happened and learned of the universe of potentially impacted data. Brock then conducted a thorough review thereof. On July 13, 2021, as a result of this review, Brock learned that personal information belonging to Maine residents may have been accessed or acquired without authorization as a result of this incident. For certain of the potentially impacted individuals, Brock worked with a third party vendor to complete advanced address searching which was completed on August 12, 2021.

As previously noted, Brock notified 7 potentially impacted Maine residents of this incident on August 10, 2021. On August 25, 2021, Brock notified 1 additional potentially impacted Maine resident of this incident via the attached sample letter. In so doing, Brock offered notified individuals complimentary identity protection services through IDX, a data incident and recovery services expert. These services included credit and CyberScan monitoring, a \$1,000,000 insurance reimbursement policy, and fully managed identity theft recovery services. Brock also reported this incident to law enforcement and will cooperate with any related investigation.
