

# **EXHIBIT 1**

We represent Hills Properties (“Hills”) located at 4901 Hunt Road, Suite 300, Cincinnati, OH, 45242, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) Maine resident. This notice may be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Hills does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

On or about December 15, 2021, Hills identified suspicious activity within certain systems in its environment. In response, Hills quickly took steps to secure its network and, with the assistance of third-party forensic specialists, began an investigation to determine the nature and scope of the activity. The investigation confirmed an unauthorized individual accessed certain information in the environment between December 7, 2021, and December 15, 2021.

Given that certain information was accessed without authorization, Hills then undertook a comprehensive review, again aided by third-party specialists, of the impacted data to understand the specific information potentially impacted and to whom it related for purposes of providing notification to potentially impacted individuals. This comprehensive review was completed on March 30, 2022. Hills thereafter worked expeditiously to provide notification.

The information that could have been subject to unauthorized access includes name and Social Security number.

### **Notice to Maine Resident**

On April 25, 2022, Hills began providing written notice of this incident to affected individuals, which includes one (1) Maine resident. Written notice is being provided in substantially the same form as the letter attached hereto as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, Hills moved quickly to investigate and respond to the incident, assess the security of Hills systems, and identify potentially affected individuals. Further, Hills promptly notified federal law enforcement regarding the event and thereafter cooperated with the investigation. Hills is also reviewing and enhancing its existing policies and procedures related to data protection and security, implementing additional security measures and safeguards to protect against this type of event in the future, and also providing additional training to its employees. Additionally, as an added measure, Hills is providing access to monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals. Hills is also notifying other relevant state regulatory authorities, as required.

Additionally, Hills is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

**Re: Notice of Data [Extra1]**

Dear Sample A. Sample:

Hills Properties (“Hills”) is writing to notify you of a recent incident that may affect the privacy of some of your personal information. We write to provide you with information about the event, our response, and steps you can take to help protect against the possible misuse of your information, should you feel it is appropriate to do so.

**What Happened?** On or about December 15, 2021, Hills discovered suspicious activity within certain systems in our environment. In response, we quickly took steps to secure our network and, with the assistance of third-party forensic specialists, began an investigation to determine the nature and scope of the activity. Our investigation confirmed an unauthorized individual accessed certain information in our environment between December 7, 2021, and December 15, 2021. Given that certain information was accessed without authorization, we then undertook a comprehensive review of the impacted data to understand the specific information potentially impacted and to whom it related for purposes of providing notification to potentially impacted individuals. We completed those efforts on March 30, 2022, and thereafter worked to provide notification to potentially impacted individuals as quickly as possible. We are notifying you because your information was present in the files accessible to the unauthorized individual, and therefore may have been accessed during this incident.

**What Information Was Involved?** Our investigation determined that the information related to you that may have been impacted includes your name and [Extra2]. While we have no evidence that any of your information was used for identity theft or fraud, we are notifying you out of an abundance of caution and providing information and resources to assist you in helping protect your personal information, should you feel it appropriate to do so.

**What We Are Doing.** We take this incident and the obligation to safeguard the information in our care very seriously. After discovering the suspicious activity, we promptly took steps to confirm our system security, and engaged third-party forensic specialists to assist in conducting a comprehensive investigation of the incident to confirm its nature, scope, and impact. Hills also promptly notified federal law enforcement, and thereafter, cooperated with the investigation. Further, as part of our ongoing commitment to the privacy and security of personal information in our care, we are reviewing and enhancing existing policies and procedures relating to data protection and security. We have instituted additional security measures to better protect against future similar incidents. We are also notifying relevant regulatory authorities, as required.

As an added precaution, we are offering you access to credit monitoring and identity theft protection services for [Extra3] months through Experian at no cost to you. If you wish to activate these complimentary services, you may follow the instructions included in the attached *Steps You Can Take to Help Protect Personal Information*. We encourage you to enroll in these services as we are unable to act on your behalf to do so.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing account statements and monitoring your free credit reports for suspicious activity and to detect errors. You should report any such activity to law enforcement. You can also enroll to receive the complimentary credit monitoring services that we are offering to you. ## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
