As you may know, there was a cyber-attack against our company in January. We have proactively decided to provide free identity theft protection to all employees as a precaution.

What Happened: On or about January 19, 2024, we discovered there was unauthorized access to our system. We brought in a company that specializes in cyber investigations. Together, we determined there was employee information in the files accessed by the unauthorized actor. On March 28, 2024, we finished our investigation and began notifying impacted individuals.

<u>What Information Was Involved</u>: The types of information contained within the potentially impacted files includes your first and last name together with your Social Security number.

<u>What We Are Doing</u>: We have already put additional cyber security measures in place to prevent similar incidents in the future. We are also providing free credit protection services to all employees as a precaution.

<u>What You Can Do</u>: Sign up for the <<12/24>> month free identity and credit protection services we are offering to all employees. The instructions for signing up are included in this letter. In addition, we have included information on how you can monitor your accounts regularly and report suspicious activity.

Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your credit reports/account statements and explanation of benefits forms for suspicious activity and to detect errors. Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit www.annualcreditreport.com or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Address for the prior two to five years;
- 5. Proof of current address, such as a current utility or telephone bill;
- 6. A legible photocopy of a government-issued identification card (e.g., state driver's license or identification card); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.
