## **APPENDIX**

On June 8, 2021, Cove concluded its investigation of a data security incident that involved unauthorized access to one employee's email account. Upon first suspecting unauthorized access to the employee's email account, Cove immediately secured the account and launched an investigation. In connection with that investigation, Cove learned that an unauthorized party gained access to the employee's email account between April 8, 2021 and April 9, 2021. Cove's investigation was unable to determine whether the unauthorized party actually viewed any emails or attachments in the account. Out of an abundance of caution, Cove reviewed the emails and attachments in the account to identify individuals whose information may have been accessible to the unauthorized party. Cove determined that an email or attachment contained the personal information of one Maine resident, including the resident's name and Social Security numbers.

On June 28, 2021, Cove is providing written notice via United States Postal Service First Class mail to the Maine resident whose personal information was potentially accessed by an unauthorized party. Cove is offering the eligible individual a complimentary one-year membership in credit monitoring and identity theft protection services through Experian. Cove has encouraged the affected residents to monitor their account statements and credit reports for fraud. Cove has also established a dedicated, toll-free call center where all individuals may obtain more information regarding the incident.

To help prevent a similar incident from occurring in the future, Cove implemented additional security measures to enhance the security of its network and retrained its employees concerning data security.



To date, we are unaware of any misuse of the information maintained in the employee's email account. Nor do we have any evidence that any emails or attachments containing your information were actually viewed. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. **Fraud Alerts:** There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

**Credit or Security Freezes:** You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
