#### **Nature of the Data Event**

On December 14, 2021, Aditi identified suspicious activity related to certain computer systems, and subsequently discovered its network was the target of a sophisticated cyber-attack. Aditi moved quickly to secure the network, and began an investigation with the assistance of third-party computer specialists to identify what happened and confirm what information may have been involved. As of December 22, 2021, Aditi determined that certain documents containing information relating to current and former employees and/or consultants had been taken from its network by an unauthorized actor on or about December 9, 2021.

The information that was acquired includes name and Social Security number.

# **Notice to Maine Resident**

On or about January 25, 2022 Aditi provided written notice of this incident to all affected individuals, which includes one (1) Maine resident. Written notice is being provided in substantially the same form as the letter attached here as Exhibit A.

# Other Steps Taken and To Be Taken

Upon discovering the event, Aditi moved quickly to investigate and respond to the incident, assess the security of its systems, and notify potentially affected individuals. Aditi is also working to implement additional safeguards and training to its employees. Aditi is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.


Additionally, Aditi is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Aditi is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Please note, you will need to enroll yourself in the services if you would like to do so, as we are unable to enroll you on your behalf.

What Can You Do. You may also activate the complimentary credit and identity monitoring services we are offering.

# **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
