This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Plano-Coudon does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On June 14, 2021, Plano-Coudon discovered that certain computer systems in its environment had become inaccessible. Plano-Coudon immediately launched an investigation and notified federal law enforcement. On June 17, 2021, the investigation determined that certain Plano-Coudon systems were accessed beginning on May 15, 2021 and some files within these systems may have been removed by an unauthorized actor sometime between June 10, 2021 and June 14, 2021.

In general, Plano-Coudon stores some sensitive information relating to vendors, employees, and their spouses and dependents on the potentially affected systems. Therefore, in an abundance of caution, Plano-Coudon is notifying potentially affected individuals based on the facts known to date to ensure that they are aware of this incident.

Notice to Maine Resident

Plano-Coudon is providing written notice to potentially impacted individuals on a rolling basis. Plano-Coudon began providing written notice of this incident on July 2, 2021 to identified potentially impacted individuals. Based on additional information from its ongoing review of the at-issue files and systems, on July 16, 2021, Plano-Coudon provided written notice of this incident to one (1) Maine resident as identified as potentially having a name and Social Security number in the involved systems. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Plano-Coudon moved quickly to investigate and respond to the incident, assess the security of Plano-Coudon systems, and notify potentially affected individuals. Plano-Coudon notified federal law enforcement and is reviewing its existing policies and procedures, modifying them as necessary. Plano-Coudon is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Plano-Coudon is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Plano-Coudon is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

What Happened?

On June 14, 2021, Plano-Coudon discovered that certain computer systems in its environment had become inaccessible. We immediately launched an investigation and notified federal law enforcement. On June 17, 2021, the investigation determined that certain Plano-Coudon systems were accessed beginning on May 15, 2021 and some files within these systems may have been removed by an unauthorized actor sometime between June 10, 2021 and June 14, 2021. We reviewed these files to determine if they contain sensitive information and then began notifying potentially affected individuals based on the facts known to date to ensure they are aware of this incident.

What Information Was Involved?

In general, Plano-Coudon stores some personal information on its systems including the name and Social Security numbers of its vendors, employees, and the spouses and dependents of its employees. Therefore, it is possible your Social Security number may have been affected by this incident.

What We Are Doing.

Plano-Coudon treats its responsibility to safeguard information in its possession as an utmost priority. Upon discovering this incident, we promptly began an investigation and took steps to assess the security of our systems. As part of our commitment to the privacy and security of personal information in our care, we are reviewing our existing policies and procedures relating to data protection and security. We are also investigating additional security measure to enhance our already robust system security and mitigate any risk associated with this incident and to reduce the likelihood of future incidents. We are providing notice of this event to potentially impacted individuals and to state regulators, where required.

Out of an abundance of caution, we are providing you with twelve (12) months of complimentary access to credit monitoring and identity restoration services through Experian, as well as guidance on how to better protect your information, should you feel it is appropriate to do so. While we are covering the cost of these services, due to privacy restrictions, you will need to complete the activation process yourself.

What You Can Do.

We encourage you to remain vigilant against incidents of identity theft and fraud, review your account statements, monitor your credit reports for suspicious activity, and to report any suspicious activity immediately to your bank or financial institution. Additional information and resources are included in the enclosed "*Steps You Can Take To Protect Personal Information*." You may also enroll in the complimentary credit monitoring services available to you. Enrollment instructions are enclosed in this letter.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
