By providing this notice, Texas Medical Liability Trust on behalf of itself and its affiliates, Texas Medical Insurance Company, Physicians Insurance Company, and Lone Star Alliance, Inc., a Risk Retention Group ("TMLT") does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

As detailed in our March 21, 2023 correspondence, on or about October 12, 2022, TMLT identified suspicious activity within their environment. TMLT immediately took steps to secure its network and launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. Through the investigation, TMLT determined that an unauthorized actor may have had access to certain systems between October 2, 2022 and October 13, 2022. As a result, certain files within these systems and information may have been accessed or acquired by the unauthorized actor during this incident. Based on the investigation, TMLT conducted a detailed review of the data involved to determine the type of information present and to whom it related.

On August 18, 2023, the review of those files was completed. The information that could have been subject to unauthorized access includes name, Social Security number, EIN/Tax Identification number, state identification or driver's license information, and financial account information.

Notice to Maine Residents

On or about March 21, 2023 TMLT began providing notice of this incident to one (1) Maine resident. Since September 11, 2023, written notice was provided to an additional twenty (20) Maine residents. The total number of individuals receiving notice in Maine is twenty-one (21). Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

TMLT notified federal law enforcement regarding the event. TMLT is also working to implement additional safeguards and training to its employees. TMLT is providing access to complimentary credit monitoring services for twelve (12) months, through Kroll, to individuals whose information was potentially impacted by this incident.

Additionally, TMLT is providing impacted individuals with guidance on how to better protect against identity theft and fraud, providing individuals with information on how to place a fraud alert, and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

TMLT is providing written notice of this incident to other state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion. TMLT also notified the U.S. Department of Health and Human Services. TMLT has posted a notice of the data event on their website and issued a press release to a major media outlet in Texas.

While we are unaware of any attempted or actual misuse of your information at this time, we are providing you with this notice in an abundance of caution, to inform you of the incident, our response, and steps you may take to help protect your information, should you feel it is necessary to do so. We are in possession of your information because we work with <

What Happened? On October 12, 2022, TMLT identified suspicious activity within our environment. We immediately took steps to secure our network, and launched an investigation, with the assistance of third-party forensic specialists to determine the nature and scope of the activity. Through the investigation, we determined that an unauthorized actor may have had access to certain systems between October 2, 2022 and October 13, 2022. As a result, certain files within these systems and information therein may have been accessed or acquired by the unauthorized actor during this incident. Based on the investigation, we conducted a detailed review of the data involved to determine the type of information present and to whom it related. We are notifying you because the investigation recently determined information related to you was contained within the files.

What Information Was Involved? We determined that the following information may have been subject to unauthorized access during this incident: your name, Social Security number, driver's license number/government issued identification, financial account information, medical treatment and diagnosis information, and health insurance information.

What We Are Doing. The confidentiality, privacy, and security of information within our care is among TMLT's highest priorities. Upon learning of the incident, we took immediate steps to secure our environment and investigate the activity. We commenced an investigation that included working with third-party forensic specialists to understand the nature and scope of the incident. We also notified federal law enforcement about this incident and are cooperating with their investigation. While TMLT had policies and procedures regarding data security, as part of our ongoing commitment to the privacy of information in our care, we are reviewing our policies, procedures, and processes related to the storage and access of sensitive information. We are also notifying applicable regulatory authorities, as required by law.

As an added precaution, we are also offering 12-months of complimentary access to credit monitoring services through Kroll. Individuals who wish to receive these services must activate by following the below activation instructions, as we are unable to activate them on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud and to review your account statements and credit reports for suspicious activity and to detect errors. You can review the enclosed *Steps You Can Take to Help Protect Your Information* to learn helpful tips on steps you can take to help protect against possible information misuse, should you feel it appropriate to do so. You may also activate the complimentary credit monitoring services we are offering to you.

Single Bureau Credit Monitoring

Fraud Consultation

You have unlimited access to consultation with a Kroll fraud specialist. Kroll's activation website is only compatible with the current version or one version earlier of Chrome, Firefox, Safari and Edge. To receive credit services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit <u>www.annualcreditreport.com</u> or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;

- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
