This notice may be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Concord Music Group, Inc. ("Concord") does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On November 16, 2022, Concord discovered suspicious activity in its network. In response, Concord immediately took steps to secure its systems and initiated an investigation into the nature and scope of the event with the assistance of third-party computer forensic specialists. The investigation determined that between November 14, 2022 and November 18, 2022, an unknown actor gained access to systems on its network and acquired certain files from these systems. After Concord identified the affected files, it engaged a data review vendor to conduct a comprehensive and time-intensive review of the data set in order to identify the type of information contained therein and to whom the information relates. On October 12, 2023, Concord received the results of this extensive review process from the data review vendor. Since then, Concord has engaged in additional work to review and verify the affected information and to locate address information for the impacted population. Following the completion of this analysis on January 12, 2024, Concord confirmed the individuals present in the affected files and moved quickly to provide direct notice to impacted individuals.

The information affected by this event varies for each individual and includes the following: name and Social Security number.

Notice to Maine Residents

On February 1, 2024, Concord provided written notice of this incident to eleven (11) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Concord moved quickly to investigate and respond to the incident, assess the security of Concord systems, and identify potentially affected individuals. Further, Concord notified federal law enforcement regarding the event. Concord also implemented additional safeguards and training to its employees. Concord is providing access to credit monitoring services for one (1) year, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Concord is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. Concord is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Concord is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

Following the completion of this analysis on January 12, 2024, we confirmed that your information was present in the affected files.

What Information Was Involved? Our review determined that the following types of information were present in the affected files that were accessed and acquired by the unauthorized actor: your name, [Extra2]. Please note that we are not aware any actual or attempted fraudulent misuse of information as a result of this incident.

What Are We Doing? The confidentiality, privacy, and security of personal information is among Concord's highest priorities, and we have strict security measures in place to protect information in our care. Upon becoming aware of this incident, we immediately took steps to secure our systems and launched a full investigation with the assistance of third-party forensic specialists. We have implemented additional security measures to further protect against similar incidents occurring in the future. We also reported this incident to federal law enforcement.

Additionally, we are offering credit monitoring and identity protection services for [Extra3] months through Experian, at no cost to you. The deadline to enroll in these services is May 31, 2024. Please note that you will not be automatically enrolled in these services. Should you wish to do so, you will need to enroll yourself in these services, as we are not able to do so on your behalf. You may find instructions on how to enroll in these services in the enclosed *Steps You Can Take to Help Protect Personal Information*.

What Can You Do? We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. There you will also find more information on the complimentary credit monitoring and identity protection services we are making available to you.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. - 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
